OFFICE MEMORANDUM

In supersession of this Department's Letter No FEA 93/2004/179 dated 19th Feb, 2020 and O.M. FEA.93/2004/180, dt.8th June 2020, the following items of expenditure and procedures are exempted from the temporary withdrawal of the Meghalaya Delegation of Financial Power Rules (DFP) 2006, circulated vide FEA93/2004/163, dt.18th July, 2019.

- 1. Items of expenditure under **'Object-heads':** 13-Office Expenses, 16-Publications, 21- Materials & Supplies, 23-Cost of Ration, 24-POL, 26-Advertising & Publicity, 27-Minor Works and 50-Other Charges.
- (a) The extent of the expenditure on the above mentioned 'Object-heads' to be incurred during a quarter will, however, be determined by allotment of LOA/LOC.
- (b) With regard to wages and payment to muster roll and work charges, the LOA/LOC will be issued at the beginning of the quarter and all concerned departments are to ensure that the wage earners, Muster Rolls, and Work Charge are paid their wages in the first week of the month through Direct Benefit Transfer (DBT) only.
- Administrative and financial procedures/processes relating to (a) Technical sanction, (b)Acceptance
 of Tender, (c) Tendering Process through DTC/DPB and (d) Declaring of state guest by Administrative
 Departments.
- 3. All Departments outside the purview of the LOA/LOC are also exempted from the letter No.FEA93/2004/163, dt.18th July, 2019 pertaining to the withdrawal of DFP, Rules 2006 subject to a quarterly expenditure limit of 20% of the total annual budget provision(except salaries & wages). These Departments will have to approach Finance(B) Department for LOA/LOC incase of additional requirement.
