## OFFICE MEMORANDUM

In partial modification to this Department's Letter No dated FEA 93/2004/163 dated 18<sup>th</sup> July, 2019 pertaining to the temporary withdrawal of the Meghalaya Delegation of Financial Power Rules (DFP) 2006, the following items of expenditure and procedures are exempted from the purview of the aforesaid letter:

Items of expenditure under 'Object-heads': 13-Office Expenses, 16-Publications, 23-Cost of Ration, 26-Advertising & Publicity, 27-Minor Works (with regard to payment to muster roll and work charges only) and 50-Other Charges.

The extent of the expenditure on the above mentioned 'Object-heads' to be incurred during a quarter will, however, be determined by allotment of LOA/LOC.

With regard to wages and payment to muster roll and work charges, the LOA/LOC will be issued at the beginning of the quarter and all concerned departments are to ensure that the wage earners, Muster Rolls, and Work Charge are paid their wages in the first week of month through Direct Benefit Transfer (DBT) only.
