Sir/Madam,

I am directed to say that on account of the implementation of the recommendations of the Meghalaya 5<sup>th</sup> Pay Commission and the double payment of salary during December 2017, there will be a significant outflow from the State Exchequer during the month and the subsequent three months of the 4<sup>th</sup> quarter of the Fiscal Year 2017-18. Therefore to enable Finance Department to effectively monitor the expenditure of the State, it has become necessary for Finance Department to withdraw the power of the Departments to make expenditure at their level by temporarily withdrawing the Meghalaya DFP Rules, 2006, until further order. In view of the above withdrawal, all expenditures to be incurred by the Departments, their district and subordinate offices will require the approval of Finance Department. You are, therefore, requested to prioritize your expenditure especially the day to day expenditure and submit your requirement to Finance Deptt for approval in time so as to avoid any dislocation in the functions of the State Government.
