Subject: 20% Cut on the Non Plan provision of the Budget 2016-17.

Sir,

In inviting a reference to the above cited subject, I am directed to inform you that it has been observed all along that certain Departments, in anticipation of shortage of their budget provision on account of any austerity cut, have been moving for exemption from the NP budgetary cut as a matter of routine and immediately after it has been imposed, thus defeating the very purpose of imposition such cuts on the Non Plan provision of the budget of the Departments which meant basically to enable the Finance Department to effectively manage the finances of the State.

In view of the above, it may be informed that, unless absolutely necessary, the Finance Department will not entertain any proposal for exemption from 20% NP Cut out of the NP Budget Provision 2016-17 till the last quarter of FY 2016-17 when the budgetary figures and expenditure of the respective Departments have firmed up enough to allow them to objectively consider whether it is really necessary for them to move for exemption.

If, however, it becomes really necessary to immediately move for the exemption from 20% cut, the same will be considered provided the judicious justifications and budgetary position are provided as per the Format below.
